WHEREAS, salaries are set by collective bargaining agreements approved by the Los Angeles City Council in accordance with the City of Los Angeles Charter, Section 219; and

WHEREAS, pursuant to negotiations with the Management Employees Association, as part of the collective bargaining agreements reached for the term of January 1, 2022, to December 31, 2025, it was agreed to establish two new DDRs and establish the salaries for the classification for the classification of CODO "A" and "B" Levels, Class Code 7271, DDR Nos. 95-72713 and 95-72714; adopt the salaries as approved by the City Council; and amend the APR to reflect the new CODO DDRs and salaries as listed below; and

*The salary range number is equal to the first step hourly rate x 100. For example, range 7786 means that range for which the first step is \$77.86 an hour (77.86 x 100).

**Salaries are based on the top salary step (Step 5) of the Operating, Maintenance and Service Unit Memoranda of Understanding for the October 1, 2023, Cost-of-Living Adjustment.

WHEREAS, the actions specified above shall be effective on the date the Board of Water and Power Commissioners adopts this Resolution.

NOW, THEREFORE, BE IT RESOLVED that the DDRs identified by the DDR numbers listed above are hereby adopted to fix the duties and responsibilities of the positions created thereunder, and the number of positions authorized is hereby fixed as set forth above; and Schedule "B" of the Position Evaluation and Compensation Plan (Resolution No. 327, adopted October 9, 1947) as amended, the Departmental Personnel Resolution (Resolution No. 328, adopted October 9, 1947) as amended, and adopted on October 28, 2022, by the City Council, is hereby further amended to reflect this action.


