SUBJECT: Contract Nos. 678A, and 678B for Medium Voltage Cable with Taihan Electric USA, Ltd. and CME Wire and Cable, Inc., Respectively

SUMMARY

The proposed Contract Nos. 678A and 678B (Contracts) are to purchase medium voltage cable for a term of one year with two one-year renewal options (estimated expiration date of August 2027), for an estimated expenditure of \$74,119,011 and an amount not to exceed \$92,648,763 (budgeted). The Contracts are the result of a competitive bid process.

The cable is for warehouse stock and will be used for new installations, replacement of old and deteriorating cable, and support for the Power System Reliability Program (PSRP). PSRP annual goals require the replacement of aging underground distribution cables that are nearing the end of their design life. The new cable installations are expected to reduce outage frequency and duration, thus maintaining the reliability of power distributed to LADWP customers.

City Council approval is not required.

RECOMMENDATION

It is recommended that the Board of Water and Power Commissioners (Board) adopt the attached resolution authorizing the award of Contract No. 678A to Taihan Electric USA, Ltd. (Taihan), the lowest bidder under Group I, and Contract No. 678B to CME Wire and Cable, Inc. (CME), the lowest bidder under Groups II and III.

ALTERNATIVES CONSIDERED

There are no other alternatives at this time. LADWP does not have the capability or facilities to fabricate the medium voltage cable materials included in the Contracts. LADWP has historically purchased medium voltage cable. Failure to procure this cable will result in an inability to construct projects that require this material.

FINANCIAL INFORMATION

The Contract is for a term of one year with two one-year optional renewal periods and is budgeted.

LADWP agrees to a minimum expenditure of 25 percent and a maximum expenditure of 125 percent of the estimated expenditures. The maximum expenditure will not exceed \$92,648,763.

The total quotation of \$74,119,011 is approximately 22 percent lower than LADWP's estimated cost of \$94,826,689. The estimate was developed using a quotation obtained from a domestic manufacturer. The variance is attributed to receiving competitive pricing from an international manufacturer.

BACKGROUND

The cables under the Contracts are essential elements of the LADWP's 34.5kiloVolt (kV) and 4.8kV underground power distribution systems. LADWP's medium voltage cables consist of an aluminum or copper conductor that is surrounded by various layers of insulation, shielding, and jacketing that make the cable suitable for each particular underground application. These cables are for warehouse stock. The new cable installations are expected to reduce outage frequency and duration, thus maintaining the reliability of power distributed to the customers of LADWP.

The specification is divided into three groups that can be awarded separately. The items are grouped based on the voltage rating and construction type. The groups cover 5kV, 8kV, 15kV, and 35kV rated cables with either ethylene propylene rubber or cross-linked polyethylene insulation. Based on past experience, LADWP was able to increase bidder participation by having separate groups.

Invitation for Bid No. 678 has escalation clauses based on three commodities. The base unit price of cable will be adjusted quarterly based on the commodity prices of copper, aluminum, rubber, and plastics.

Taihan and CME have performed satisfactorily on previous and current contracts.

ENVIRONMENTAL DETERMINATION

Determine item is exempt pursuant to California Environmental Quality Act (CEQA) Guidelines Section 15060(c)(3). In accordance with this section, an activity is not subject to CEQA if it does not meet the definition of a project. Section 15378(b)(4) states that government fiscal activities which do not involve any commitment to any specific project which may result in a potentially significant physical impact on the environment do not meet that definition. Therefore, the contract for medium voltage cable is not subject to CEQA.

CITY ATTORNEY

The Office of the City Attorney reviewed and approved the Resolution as to form and legality.
