

**AMENDMENT NO. 1 TO AGREEMENT NO. 47677A
BETWEEN
THE LOS ANGELES DEPARTMENT OF WATER AND POWER
AND
GE VERNOVA INTERNATIONAL LLC**

THIS AMENDMENT NO. 1 to Agreement No. 47677A is made and entered into by and between the City of Los Angeles acting by and through the Los Angeles Department of Water (hereinafter "LADWP"), a municipal corporation, and GE Vernova International, LLC (hereinafter the "Consultant" or "Contractor"), a Delaware corporation with a principal place of business at 4200 Wildwood Parkway, Atlanta, GA 30339. Individually, LADWP and Consultant are referred to under this Amendment as a "Party" and collectively as the "Parties."

WHEREAS, the Parties have entered into Agreement No. 47677A (Agreement) wherein the Contractor agreed to furnish and deliver proprietary professional, technical, and repair services and parts for the not-to-exceed amount of \$160,000,000, effective September 20, 2021 for a term of five years, which together with all amendments and supplements thereto herein after shall be referred to as the "Agreement;" and

WHEREAS, the Parties are amending the Agreement for the purpose of increasing the not-to-exceed amount of the Agreement by \$105,000,000 to a new not-to-exceed amount of \$265,000,000.

NOW, THEREFORE, that for good value and consideration including mutual exchange of promises, the Parties hereby agree to amend Agreement No. 47677A as follows:

1. Article IV: Compensation and Payment, 4.1 Compensation, 4.1.1: Not-to-Exceed Amount currently reads:

"The total cumulative compensation that may be paid to be the Consultant by LADWP pursuant to this Agreement and Agreement 47677B for complete and satisfactory performance of services shall not exceed One Hundred and Sixty Million dollars (\$160,000,000)."

is hereby amended as follows:

"The total cumulative compensation that may be paid to be the Consultant by LADWP pursuant to this Agreement and Agreement 47677B for complete and satisfactory performance of services shall not exceed Two Hundred and Sixty-Five Million dollars (\$265,000,000)."

Except as amended herein, all terms and conditions of Agreement No. 47677A shall remain in full force and effect.

This Amendment No. 1 may be executed in one or more counterparts, and by the parties in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same amendment. The parties further agree that facsimile signatures or signatures scanned in to .pdf (or signatures in another electronic format designated by LADWP) and sent by e-mail shall be deemed original signatures.

This Amendment No. 1 consists of three (3) pages.
